

The hearing on Plaintiffs' application for a Temporary Restraining Order came on regularly for hearing before this Court on July 18, 2008, at 1:30 p.m., the Honorable James C. Emerson presiding. Having come on

1 regularly for hearing, and after considering all papers and oral arguments of  
2 counsel for the parties, Plaintiffs' application for a Temporary Restraining  
3 Order is hereby **GRANTED**.

4 The Court HEREBY FINDS as follows:

5 1. Plaintiffs possess a valid Public Entertainment Business Permit to  
6 do business as Sabor, and shall not be restrained from engaging in said  
7 business.

8 2. All business permit fees collected since June 1, 2008, shall be  
9 refunded forthwith to Plaintiffs. Plaintiffs, and their managers, shall be  
10 fully restored to their status with the City of San Jose as of June 1, 2008.  
11 Any renewal application submitted by Plaintiffs shall be assessed the  
12 application fee as if it was June 1, 2008.

13 3. This Temporary Restraining Order is against Defendant City of San  
14 Jose only.

15 4. The Temporary Restraining Order shall be valid and in full force  
16 and effect. A hearing on the Preliminary Injunction shall be held on  
17 September 12, 2008, at 9:00 a.m. in Department 19.
