The following is an overview of the draft poll questionnaire and methodology approach.

- **Research Goal** The purpose of the poll is to evaluate potential voter support for a revenue measure to be placed on either the June OR November 2016 ballot by the County.
- Overview The poll is designed to identify baseline (opinion today) and informed (opinion after more information is provided) support for three potential revenue measure options. In order to provide unbiased evaluation of each option, we recommend using a split sampling methodology whereby each sample hears only one of the revenue measure(s) options.
  - "Sample A" will evaluate support for a general sales tax with an • accompanying advisory measure directing funds to county services including transportation, housing, public safety and health care.
  - "Sample B" will evaluate support for a general sales tax with an • accompanying advisory measure directing funds for transportation improvements including BART, pothole repair, Caltrain improvements, bike and pedestrian safety and expressway improvements.
  - "Sample C" will evaluate support for a special sales tax directed • specifically to transportation improvements.

Survey structure The questionnaire follows a very standard format for testing a revenue measure.

- Questions 1-5 are general screening and warm-up questions.
- Questions 6-9 are the baseline tests of potential revenue measures. Each sample will only hear one of the options, not all of the questions. For the general tax measures, voters will hear the advisory measure first followed by the general sales tax question.
- In questions 7 and 9 we are testing an additional sub option. One version • will include only transportation projects and an alternate version will include transit oriented development ("provide affordable homes near public transit") in addition to the transportation projects. Respondents will hear only one or the other version. This methodology will allow us to

see if including housing in the ballot question has any impact on overall support.

- Questions 10 through 13 are general attitudinal and values questions that we have asked in the county before. We find these questions are valuable in understanding overall voter attitudes regarding taxes and we will be able to provide trend data to show how attitudes today compare with previous years.
- Questions 14-34 test voter support for the individual components of the potential measures. Samples B and C will hear about transportation specific projects, sample A will hear about transportation and additional projects that could be funded for the county.
- Questions 35-38 re-ask the ballot questions to see if support has changed after additional information.
- Questions 39-42 test voter reaction to potential opposition messaging.
- Questions 43-46 re-ask support for the measure(s) after hearing opposition messaging
- the survey finishes with a few demographic questions
- MethodologyThe poll will be a telephone survey of 1500 likely November 2016 voters in Santa<br/>Clara County. Our analysis will include a close look at the subsample of voters that<br/>are likely to vote in the June 2016 election to provide a comparison of the June<br/>and November electorates. The survey will be offered in English, Spanish,<br/>Vietnamese and Chinese and our sample will include both landline and cell<br/>phones.
