- As of September 30, 2016, wealthy special interests have spent more than \$3 million (\$3,049,117) to elect Madison Nguyen and defeat Ash Kalra.
- Via "Independent Expenditure" these interests have spent \$2,889,716 to elect Nguyen:

 Total anti-Kalra IEs though 9/29/2016: \$607,897

Funded by the CA Charter Schools Association Advocates IE Committee (ID 1339522) this group gained attention for laundering \$2.3 million in "dark money" contributions from wealthy charter school backers in the 2015 Los Angeles school board election that were not disclosed until months after the election. Major donors this cycle include:

- \$654,000 from Alice Walton and \$225,000 from Jim Walton, children of Wal-Mart founder Sam Walton and major donors to Republicans and charter school initiatives around the country. They each gave \$200,000 to Restore Our Future, the super PAC associated with Mitt Romney's 2012 run for President and tens of thousands of more to federal Republican committees.
- The Wisconsin Center for Investigative Journalism reported in September 2011 that Alice was the top individual contributor to winning state legislative candidates in the 2010 elections that put Republicans in control of the state government, handing control to Gov.
