The undersigned is informed and believes that:

COUNT 1

On or about January 31, 2020, in the County of Santa Clara, State of California, the crime of VANDALISM - FOUR HUNDRED DOLLARS AND MORE, in violation of PENAL CODE SECTION 594(b)(1), a Felony, was committed by SUKHDEEP SINGH GILL who did maliciously damage and destroy property, specifically, a body worn camera and a Santa Clara County Sheriff's Office patrol vehicle, not his/her own, in the amount of four hundred dollars (\$400.00) and more.

COUNT 2

On or about and between January 31, 2020 and February 1, 2020, in the County of Santa Clara, State of California, the crime of FALSELY REPORTING CRIME, in violation of PENAL CODE SECTION 148.5(a), a Misdemeanor, was committed by SUKHDEEP SINGH GILL who did report to a peace officer a felony, attempted murder and assault with a deadly weapon, knowing such a report to be false.

Any defendant, including a juvenile, who is convicted of and pleads guilty and no contest to any felony offense, including any attempt to commit the offense, charged in this complaint or information is required to provide buccal swab samples, right thumbprints and a full palm print impression of each hand, and any blood specimens or other biological samples required pursuant to the DNA and Forensic Identification Database and Data Bank Act of 1998 and Penal Code section 296, et seq.

Further, attached and incorporated by reference are official reports and documents of a law enforcement agency which the complainant believes establish probable cause for the arrest of defendant SUKHDEEP SINGH GILL, for the above-listed crimes. Wherefore, A WARRANT OF ARREST IS REQUESTED.

Complainant therefore requests that the defendant(s) be dealt with according to law.
